

CAMPER/PARENT/GUARDIAN **GENERAL RELEASE** FOR "MOPETE'S SEVENTH ANNUAL FLINTSTONE CHARITABLE BASKETBALL CAMP" ON JULY 12, 13, AND 14, 2011 AT FLINT NORTHWESTERN HIGH SCHOOL

FOR AND IN CONSIDERATION of the right and privilege to participate as an athlete and camper in the basketball camp known as MoPete's Seventh Annual Flintstone Charitable Basketball Camp (the ACamp@) coordinated by Morris Peterson (ACoordinator@) and conducted in cooperation with Flint Northwestern High School and the [Flint Community School District?] ("Flint School District") to benefit the youth of the Flint community where Coordinator grew up, which is to be held Tuesday through Thursday, July 12, 13, and 14, 2011, at the Flint Northwestern High School gymnasium, and for the additional sum of one dollar (\$1), transfer and receipt of which is hereby acknowledged, the undersigned camper and/or parent or guardian of said camper (all of whom, on behalf of said camper, shall hereinafter be jointly referred to as AReleasor@) hereby agrees to the following:

Releasor hereby releases, and forever discharges Coordinator and Flint School District and all of their associates, agents, representatives and employees (hereinafter AReleasees@) from all liability, claims, equity, whether for personal injury or property damage or otherwise, relating whether directly or indirectly to the Camp, and which Releasor now has, or may in the future have (and which any personal representative, successor, heir or assign of Releasor now has, or may in the future have) against Releasees (the AClaims@).

Releasor hereby expressly waives and assumes the risk of any and all Claims (including without limitation injuries occurring during the Camp) which may exist as of this date or which may occur during the Camp, and hereby represents that the camper designated below is physically fit and capable in all respects to participate in such Camp. If said camper is a minor, Releasor hereby represents and warrants that his parent (s) and/or legal guardians have consented and approved his participation in the Camp, and execution of this Release.

This Release constitutes the entire agreement between the parties and supersedes all prior discussions, negotiations, agreements or promises regarding the Claims. There are no other agreements or representations between the parties whether expressed or implied regarding the Claims.

Releasor confirms that he has read and understood the legal consequences of this Release, and further understands that Coordinator and Flint School District would not have organized the Camp without the protections of this Release. This Release shall be governed and construed in accordance with the laws of the State of Michigan, with the intent and purpose to eliminate to the maximum extent possible any Claims against Coordinator and/or Flint School District, who are organizing the Camp voluntarily and solely for charitable purposes.

This Release shall be binding upon any successors and assigns of Releasor and shall inure to the benefit of Releasees.
